

Data protection regulations concerning the AWARE Newsletter

The following data protection information refers to the use of the "AWARE" newsletter from the University of Applied Sciences Ingolstadt.

1. Use of your data

- 1.1 You receive this newsletter about the Bavarian Center for Applied Research and Technology with Latin America short: AWARE Center, with which you are connected as a partner or an interested party. We want to inform you about current developments, important topics and dates of the AWARE Center and thereby enforce networking (within the meaning of Art. 6 Abs. 1 lit b and e DSGVO). If you should not be a partner of the University of Applied Sciences Ingolstadt, you receive this newsletter at your own request by providing your consent to the University of Applied Sciences Ingolstadt within the meaning of Art. 6 Paragraph 1 lit. Your data will only be electronically stored, processed and used by the University of Applied Sciences Ingolstadt for sending the newsletter in a machine-readable manner. The University of Applied Sciences Ingolstadt only saves your data for as long as you are subscribing the newsletter. As soon as you unsubscribe, your data will be deleted.
- 1.2 The University of Applied Sciences Ingolstadt stores your first and your last name in order to enable addressing you personally. We require your e-mail address in order to be able to send you the newsletter.

2. Right of withdrawal

If you should receive this newsletter based on your consent, you can revoke it at any time by sending an e-mail to aware@thi.de.

3. Affected rights

According to the General Data Protection Regulation, you obtain the following rights:

- 3.1 If your personal data is processed, you obtain the right to receive information about the data that is stored about you (Art. 15 GDPR).
- 3.2 If incorrect personal data is processed, you have the right of rectification (Art. 16 GDPR).
- 3.3 If the legal requirements should be met, you may request the deletion or the restriction of processing and object this processing. (Art. 17, 18 und 21 GDPR).

- 3.4 If you agreed on the processing of your data or if there is a contract concerning data processing and data processing is carried out by using automated procedures, you may be entitled to the right of data portability. (Art. 20 GDPR).
- 3.5 If you should make use of your above-mentioned rights, a public body will check whether the legal requirements for this action have been met.
- 3.6 Further, there is a right of appeal to the Bavarian State Commissioner for Data Protection.
